3 SCOPE OF WORK

Under the scope of this RFE, the MAP_IT wishes to empanel and engage vendors having experience in conducting performance and load testing of applications as and when there is a requirement. At the time of requirement, the MAP_IT would be floating a limited quotation to the empaneled vendors with detailed scope of work. Eligible vendor would be awarded the contract of work based on the techno-commercial response submitted by them in response to the limited quotation. The decision of the MAP_IT in this regard will be final and binding on the bidder.

The broad Scope of work in limited quotation would involve **one or more** (but not limited to) of the following:

- 6 The work would be carried out in the designated premises of and by MAP_IT.

4 GENERAL TERMS AND CONDITIONS:

Clarification about the RFE: Vendors shall have the opportunity to clarify doubts pertaining to the RFE document in order to clarify any issues they may have, prior to finalizing their responses. All questions are to be submitted to the email address mentioned in this document, and should be received by no later than the time specified in this document. If the bid is sent through post / courier, the bidder should ensure that the cover reaches us before the due date and time.

Timely Submission: Bidders are solely responsible for timely delivery of the bids to the location as mentioned above, set forth herein prior to the stated Proposals Submission due date and are solely responsible for delays in receipt, including but not limited to third party carriers. Proposals not received on or before the last date and time of submission will not be considered.

Opening of Bids: Proposals will be opened in the presence of Bidder's representatives (if present). The MAP_IT reserves the right at any time to postpone or cancel a scheduled bid opening. The bids will be opened at the address mentioned above.

5 EVALUATION METHODOLOGY

The Bid evaluation shall be a two stage process.

5.1 First Stage of Evaluation:

Preliminary scrutiny of the response to RFE will be made to determine whether they are complete, the documents have been properly signed; the response is generally in order and in the prescribed format with details filled in. The documentation furnished by the bidder will be examined prima facie to see if the submissions meet all the eligibility criteria as specified below:

5.3 Second Stage of Evaluation:

The Evaluation Committee will evaluate the technical proposals on the parameters specified under this section on the basis of the information furnished by the bidders in the technical response. The MAP_IT reserves the right to ask bidder(s) for additional information, visit to the bidders site and/or arrange discussions with their professionals, technical faculties to verify claims made in RFE response documentation.
