Request for Quotation (RFQ)

1. CoE, MAP_IT Introduction

2. EXECUTIVE SUMMARY

The companies are requested to send the Quotation for the testing the application under 2000 Virtual Users (VUs) for Oracle OATS version 12.5 or latest version.

3. SCOPE OF WORK

The Center of Excellence, MAP_IT, Bhopal- wants to Performance Test one of its application for a concurrent load of 2000 Virtual Users for various scenarios. The Performance Test tools should measure the application for critical parameters such as –

- a) Memory Leakages
- b) CPU Utilization
- c) Transaction Timeout
- d) Transaction Response Time
- e) 90 % Users' Response Time
- f) Average Response Time

It is desirable that the companies which wish to participate, send their quotations for license for 2000 Virtual Users, for **Oracle OATS version 12.5 or latest version** for a minimum duration of 10 days which may get extended up to a maximum of 14 days

In case of any discrepancy of price quoted in figure and words, the price quoted in words will be considered for the evaluation.

5. Evaluation of Financial Proposal

The Lowest Price Quotation will qualify as L1 for Performance Testing License as SaaS and will be considered for the award of the purchase order. In case L1 fails to supply the license & product, MAP_IT reserves the right to award the purchase order to L2 at the same price of L1. The Financial proposal will be opened at MAP_IT on 1st June 2016 2.30 PM. Bidder may present during opening of the proposal, if they desire so.

6. 'Request for Quotation' Format

The interested companies shall send their commercial details in the attached prescribed format latest by 31st May 2016 1430 Hrs to MAPIT by Courier/Normal / Registered post only. Any communication apart from postal communication shall not be accepted. The commercials shall explicitly mention the tool name and commercial associated with it. The commercials shall be all inclusive of all applicable taxes and levies.

The following documents are expected to be submitted by the vendor with the proposal

- a. Incorporation status and Registration Number of the company
- b. PAN number and validity of the company
- c. Service Tax Number and its validity
- d. Company Profile

The format of 'Request for Quotation' is attached as Annexure 1. Along with the Annexure -1, Bidder has to submit security deposit of **Rs. 10,000/- (Ten Thousand Only)** in the form of **Demand Draft** valid up to 30th August 2016, favouring '**MAPIT Bhopal**' Payable at Bhopal. The financial proposal must be sent in a sealed envelope with Courier/Normal /Registered post only latest by **31st May 2016 1400 Hrs.**

7. Resolution of Disputes

In case of a dispute or difference arising between the MAP_IT and the successful bidder relating to any matter arising out of or connected with the agreement, such disputes or difference shall be settled in accordance with the Madhya Pradesh Madhyastam Adhikaran Adhiniyam 1983.
